I have purchased a **Deductible Reduction Agreement** "DRA" to reduce my risk from the deductible amounts shown above to USD\$500 for the vessel and USD\$100 for the tender and outboard for inventory losses or damage ABOVE THE WATERLINE. This amount (\$600) is secured with a CASH Security Deposit.

I have purchased a **Deductible Reduction Agreement** "DRA" to reduce my risk from the deductible amounts shown above to USD\$1500 for the vessel, USD\$1500 for the tender and USD\$1500 for the outboard engine for damage BELOW THE WATERLINE AND/OR LOSS OF THE TENDER. I understand that this means that I am potentially responsible for up to USD\$4500 (\$1500 to the vessel, \$1500 to the tender and \$1500 to the outboard engine).

I am aware that CYOA has a file of digital underwater images of the yacht and I have inspected this file, or, by my initial in this box,  waive this inspection. I acknowledge and agree that I have 12 hours to report by phone (340-777-9690), or email ([info@cyoacharters.com](mailto:info@cyoacharters.com)) any underwater damage that I see and feel was not reflected in the image gallery I viewed. I agree that any damage CYOA finds at the end of my charter will have occurred during the time the vessel was under my care, custody and control and is my responsibility and I unconditionally authorize CYOA to charge the credit card listed below for the full amount I am responsible for.

I acknowledge that I am responsible for returning the vessel to CYOA with full water and diesel fuel tanks. I understand that CYOA checks each diesel tank for fullness by pouring fuel from jerry cans. I understand that any fuel poured into the vessel is my financial responsibility and authorize CYOA to charge my credit card listed below for such fuel at the rate of \$10 per gallon.

I acknowledge that CYOA will be Pre-Authorizing the sum of USD\$1500 on my credit card. I unconditionally authorize CYOA to charge the credit card listed below for the full amount I am responsible for.
